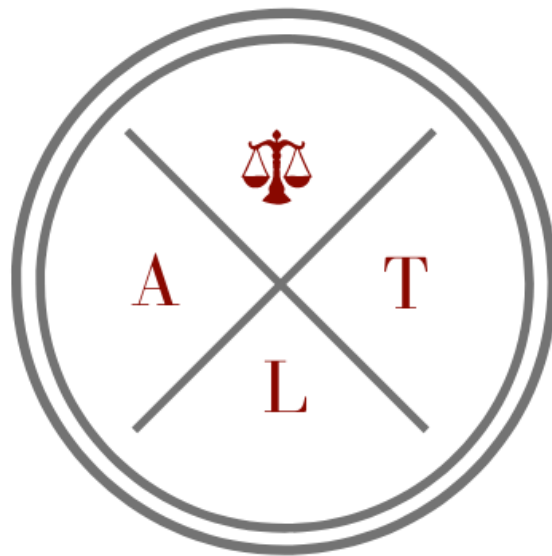


# Final pleading schedule

## First round ALT





## Instructions

Each of the sessions will take an hour. During each session, the student-lawyers of both sides will orally plead their case, rebut the arguments made by the other party and answer questions asked by the court. All members of a lawyer team are expected to speak during the hearings. For each session, the student-judges will form a court of two judges. The student-judge whose name is first on the pleading schedule will be the first to preside. The roles will be reversed for the second trial. The last trial will be joint-presided by both student-judges. At the end of each session, the student-judges will deliberate and afterwards publicly and orally deliver their judgement. In schedule form, each session will be structured as follows:

| 5 minutes  | Remaining questions by the court + closing trial |
| 7 minutes  | Deliberation judges                              |
| 5 minutes  | Public delivery of the judgement                 |

After the trials, the jury will have one hour to deliberate (**from 16:00 to 17:00**) on the participants that will move on to the final round. This deliberation will be held in **room E 0.12**.

Student-lawyers should only come to the Oudemanhuispoort at the time of their trials and leave afterwards. They should however come back for the announcement of the winners which will be held from **17:00 to 18:00 in room D 0.09**.
